### ACTION ITEMS

#### **2012-06-002 Acceptance of the Track and Football Field Complex Base Bids and Alternate Bids**

It was moved by Mr. Pochard and seconded by Mrs. Robertson to accept the general construction base bid and alternates C1, C3, C5 and C6 and electrical base bid and alternate E1 as shown in Exhibit B. ACI Construction's general construction base bid is \$1,038,000 with additions for alternate C1 (NE Concrete Drive) of \$28,200; alternate C3 (Concrete Perimeter Walk) of \$36,500; alternate C5 (Chain Link Fencing) of \$37,600; alternate C6 (Masonry Piers) of \$16,200. Bodie Electric's electrical base bid is \$115,480 with an addition for alternate E1 (Sports Lighting) of \$139,122. It was also noted that the scope of this project is more than just a new track. The construction of the new Millstream required the relocation of various fields and infrastructure which is also part of this project. (EXHIBIT B)

#### **2012-06-003 Approval of Track and Football Field Complex Finish Line Building Alternate Bids**

It was moved by Mrs. Dysinger and seconded by Dr. Siebenaler Wilson to approve alternate C4 and E2 in addition to the previous motion for a finish line building. The addition of these alternates did not change the successful bidders as approved in the previous motion. ACI Construction's bid on alternate C4 (Finish Line Building) is \$47,700 and Bodie Electric's bid on E2 (Finish Line Building Electrical) is \$5,680. Mrs. Lockard noted that while the track will be an excellent addition, the finish line building was not part of the original recommendation. She indicated her thought that there may be better uses for that \$53,380 of PI funds. She also suggested the possibility that the structure could perhaps be funded with private donations as a future project.
